GREEN & CLEAN CURL DEFINING LEAVE-IN

PROCESS :

Heat Phase A until 82°C while stirring gently.

Make a premix [Amigum + Glycerin] and add into phase A (600 rpm) for 30 minutes.

Heat phase B up to 82°C.

Then add B into A, under high agitation (900 rpm).
Maintain agitation and temperature for 10 minutes.

Allow to cool down to 50°C at 700 rpm.

At T=50°C, add a cold-water bath and maintain stirring speed.

Add phases C to E at T<30°C (900 tr/min).

APPLICATION :

Hair Care ; Curl Defining ; Leave-In (Apply on damp hair).

Galenic : Emulsion O/W

pH = 3,90 ± 0,20

Viscosity (RV M04 V10) = 15 000 mPa.s (± 10%)

Stability OK at 1 Month (RT ; 40°C and 50°C)
